INDIAN EDUCATION FALL 2008 ANNUAL DATA COLLECTION SUMMARY



This summary reflects the responses from 842 schools in October 2008 regarding Indian Education for All and Indian Student Achievement.

Does your district have a board approved policy on the implementation of MCA 20-1-501, Indian Education for All?

- Yes – 820 (97.4%)
- No – 22 (2.6%)
- On last year’s survey, 784 (93%) schools said yes and 60 (7%) said no.

Have your school board members received training regarding Indian Education for All in the past year?

- Yes – 399 (47.4%)
- No – 443 (52.6%)

Have your administrator(s) received training regarding Indian Education for All in the past year?

- Yes – 749 (89%)
- No – 93 (11%)
